FIRST AMENDMENT TO
DECLARATION OF COVENANTS,

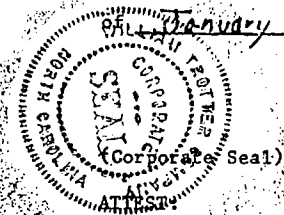

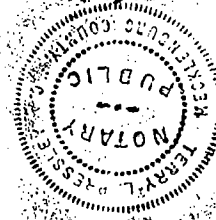
